

CONSENT

Personal data are herein defined as any information collected and registered in a format which allows you to identify yourself personally, directly (e.g. Name) or indirectly (e.g. Telephone number) as an individual. Before providing us with this information, we recommend you to read the remaining part of this document, describing our Confidentiality Policy for our clients. This policy referring to personal data is part of the rules and conditions governing our services. By accepting our conditions, you explicitly agree with the provisions of this Personal Data Protection Policy.

PERSONAL DATA PROTECTION POLICY

INTERPLAN 17 OOD (Ltd.) is a personal data controller and, in this capacity, the company collects, processes and stores your personal data in compliance with the requirements of our national legislation and the legislation of the European Union.

For that reason, we assume the obligation to observe the Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, as well as the Personal Data Protection Act, promulgated in State Gazette (SG) No. 1 of 4 January 2002, amended SG No. 17 of 26 January 2019. In order to ensure the performance of the contract with you, we have to request from you, as our client, personal information, yours and/or such of your family members, like:

- Contact details (e.g. family name, first name, telephone number, e-mail, ...);
- Personal information (e.g. date of birth, citizenship, ...);
- Number of your bank account (for the purposes of the transaction and reservation);
- Your questions / comments during or after the stay at our unit;
- Keeping a register on reservations and payments via bank transfers and cash payments on the spot in the unit.

Pursuant to the requirement of Art. 116 of the Tourism Act:

- Keeping a register of Bulgarian tourists;
- Keeping a register of foreign tourists.

The collection of information about persons under the age of 18 years is limited only to their names, nationality and date of birth, whereby these data may be presented to us by an adult only.

The data processing is carried out for the concrete purposes which are exactly fixed by the law, whereby the data shall be processed pursuant to the principles of lawfulness and fairness and may not be processed additionally in a way not consistent with these purposes.

We don't collect confidential information, like for instance racial origin or ethnicity, political opinions, religious and philosophical beliefs, membership in professional unions, details about health or sexual orientation.

Interplan 17 OOD does NOT disclose personal data to third persons and recipients, unless there is a legal basis for receiving the data or the data are generally accessible.

Recipients of data may be:

- State bodies and organs tasked with public functions, within their area of responsibility (National Revenue Agency, National Social Security Institute, Ministry of Internal Affairs, Municipal Administration);
- Banks – for the purposes of effecting payments of remunerations;
- Courier companies and postal operators – for the purposes of realizing correspondence with the individuals who are data subjects.

A permanent video monitoring is performed on the territory of Inter Holiday Apartments. The objectives of this monitoring are: protection of the guests, personnel and property, prevention of thefts, property damage and criminal actions on part of unconscientious visitors and employees of the hotel. Your personal data which are on the records created through the video monitoring systems shall be stored in a separate video monitoring register for a period of 30 days.

You have the right of access to these video records, in the part concerning specifically you.

Your personal data which are on the records created through the video monitoring devices shall not be subsequently processed for any other purpose and shall not be passed over to third persons and companies.

We use cookies and when you visit and use the web site of Inter Holiday Apartments, we collect other data which do not directly disclose your personality (pseudonymisation) but the use of our site by you, like for example the number of your visits on our site. So we preserve our right to send you e-mails, online and mobile advertisements.

Interplan 17 OOD implements the appropriate technical and organizational measures, in compliance with the applicable legal provisions, in order to protect your personal data against unlawful or accidental destruction, accidental loss or alteration, or unauthorized disclosure or access.

We store your personal data only within the period necessary for the objectives indicated in this Policy, or as provided for in the applicable legislation.

Every our guest accommodated and registered at Inter Holiday Apartments, town of Pomorie, has right to request access to his personal data, correction, right to restriction of processing, as well as right to object to the conditions in connection with the exercising of these rights.
